

The rules for re-sitting/re-taking EPA assessment methods, and End-Point Assessment as a whole, vary from standard to standard. If the assessment plans specify particular requirements for re-sits and/or re-takes, these take priority over the **NCFE EPA cancellation and re-sit/re-take policy** and are detailed in this Appendix A below.

*(**AP**) = Assessment Plan stipulation

*(**NCFE**) = NCFE EPA Policy/process

Generic NCFE re-sit/take approach guide:

Re-sits for all methods except Tests (MCQ, SJT.. etc)

The original failed criteria will be covered by our IEPA, but the apprentice will be allowed to further expand on previous passed criteria should they wish. For **Observations with Q&A** methods, apprentices have the option to re-sit remotely if **three or fewer** criteria were initially failed.

Further Learning

In all cases, evidence of further learning must be evidence after two attempts have been made.

Timescales

The timescale for resit attempts and evidence submission dates may differ based on whether the apprentice *attempted* the assessment in question. See **NCFE EPA cancellation and re-sit/re-take policy Section 5**.
