### About this qualification

The purpose of this qualification is to provide learners with the knowledge and understanding required to enter the spectator safety sector. The qualification is mapped to the SkillsActive Spectator Safety NOS suite 2019. This qualification is specifically suited to volunteers at spectator events supporting more experienced members of staff.

#### This qualification aims to:

- focus on the study of a Steward at spectator events
- offer breadth and depth of study, incorporating a key core of knowledge.

#### The objectives of this qualification are to give the knowledge and understanding to:

- prepare for spectator events
- assist with the movement of spectators and deal with crowd issues at events
- manage and resolve conflicts
- deal with incidents at spectator events
- support the work of the team and organisations

#### **Qualification structure**

Learners must achieve 5 mandatory units.

Learners must also show evidence of attending the Action Counters Terrorism (ACT) eLearning counter terrorism training, prior to certification.
