Marking guidelines

General guidelines

You must apply the following marking guidelines to all marking undertaken throughout the marking period. This is to ensure fairness to all students, who must receive the same treatment. You must mark the first student in exactly the same way as you mark the last.

- The mark scheme must be referred to throughout the marking period and applied consistently; do not change your approach to marking once you have been standardised.
- Reward students positively giving credit for what they have shown, rather than what they might have omitted.
- Utilise the whole mark range and always award full marks when the response merits them.
- Be prepared to award zero marks if the student's response has no creditworthy material.
- Do not credit irrelevant material that does not answer the question, no matter how impressive the response might be.
- The marks awarded for each response should be clearly and legibly recorded in the grid on the front of the question paper.
- If you are in any doubt about the application of the mark scheme, you must consult with your team leader or the chief examiner.

Guidelines for using extended response marking grids

Extended response marking grids have been designed to assess students' work holistically. They consist of bands-based descriptors and indicative content.

Bands-based descriptors: each band is made up of several descriptors for across the AO range, AO1 to AO3, which, when combined, provide the quality of response that a student needs to demonstrate. Each band-based descriptor is worth varying marks.

The grids are broken down into bands, with each band having an associated descriptor indicating the performance at that band. You should determine the band before determining the mark.

Indicative content reflects content-related points that a student may make but is not an exhaustive list. Nor is it a model answer. Students may make all, some or none of the points included in the indicative content as its purpose is as a guide for the relevance and expectation of the responses. Students must be credited for any other appropriate response.

Application of extended response marking grids

When determining a band, you should use a bottom-up approach. If the response meets all the descriptors in the lowest band, you should move to the next one, and so on, until the response matches the band descriptor. Remember to look at the overall quality of the response and reward students positively, rather than focussing on small omissions. If the response covers aspects at different bands, you should use a best-fit approach at this stage and use the available marks within the band to credit the response appropriately.

When determining a mark, your decision should be based on the quality of the response in relation to the descriptors. You must also consider the relative weightings of the assessment objectives, so as not to over/under credit a response. Standardisation materials, marked by the chief examiner, will help you with determining a mark. You will be able to use exemplar student responses to compare to live responses, to decide if it is the same, better or worse.

You are reminded that the indicative content provided under the marking grid is there as a guide and therefore you must credit other suitable responses a student may produce. It is not a requirement either that students must cover all the indicative content to be awarded full marks.

Assessment objectives

This assessment requires students to:

You are working as a dental nurse in a dental practice. A patient has complained as they feel their dental notes do not reflect the conversation regarding possible treatment options. Your manager arranges a performance review meeting with you.

Using your knowledge of the purposes of organisational grievance policies and procedures, explain one reason why a performance review would be performed.

AO2 = 2 marks

Award **one** mark for each explanation point, up to a maximum of **two** marks:

- A performance review should be conducted to establish the facts regarding the patient complaint (1). This ensures appropriate action can be taken following the complaint and/or a factual account can be given to the patient (1).
- A performance review should be conducted to give/facilitate feedback to support you to improve your performance regarding your note taking/documentation (1). This will provide further training/education to support your performance within your role (1).
- A performance review provides an opportunity for you to raise concerns and/or ask any questions regarding the patient complaint (1). This will support open and honest dialogue between you, the employer and the patient (1).
- The performance review may identify any disciplinary policy/actioning disciplinary procedures that may need to take place because of your performance/behaviour if any documentation errors have been made (1). These actions can be reported to the patient. The disciplinary action will be proportionate/appropriate for any errors made (1).

- The performance review will maintain expectations and standards for work conduct within your current job role in regard to documentation/note taking (1). This will ensure that the student is aware of the expectations of their job role (1).
- The performance review will identify clear goals for the student's continual professional development within the dental practice (1). This will address any learning needs that need to be addressed or competencies that must be met (1).

Accept any other suitable response.

Amelia and Tanveer work together in a dental practice. Amelia is a dentist and Tanveer is a dental nurse.

Explain two differences between Amelia and Tanveer's occupations and training, as defined by the Institute for Apprenticeships and Technical Education occupational maps.

Award **one** mark for each explanation point, up to a maximum of **four** marks:

- Amelia has a professional occupation (1) whereas Tanveer has a technical occupation (1).
- Amelia's occupation requires a degree or degree apprenticeship (1) however, Tanveer's occupation requires training at level 3 (1).
- Amelia's occupation requires her to carry out treatments on patients (1) whereas Tanveer's occupation requires him to assist a dentist to deliver treatments (1).
- Amelia's occupation gives her the ability to become a partner in a dental practice or set up her own dental practice (1) whereas Tanveer would need to complete a dentistry degree to do the same thing (1).
- The entry requirements to become a dental nurse require a minimum of 2 GCSEs (1) whereas to become a dentist you need 3 A levels (1).
- Dental nurse training takes 1–2 years (1) whereas dentist training is 5 years (1).

- 4 Marco has visited his general practitioner (GP) several times with repeated throat infections. Marco has received a letter for an appointment with the hospital's ear, nose and throat (ENT) outpatient department where he will be seen by members of the multidisciplinary care team.
 - (a) Define the meaning of the term 'multidisciplinary team'.

- Individuals who have different roles within the healthcare team (1).
- Different professionals all providing care for an individual (1).

(b) Explain why the GP has referred Marco to the ENT secondary care services.

Award **one** mark for each explanation point, up to a maximum of **two** marks:

- Secondary care will give Marco the opportunity to be seen by an ENT specialist (1) who will be able to advise about specific treatments (1).
- The GP requires a second opinion from a specialist (1) and can only offer Marco limited treatment (1).

NB: Do not accept 'to access care from a multidisciplinary team'.

5 Identify three external factors that can impact on the activities of the healthcare sector.

Award **one** mark for each named external factor that can impact on the activities of the healthcare sector, up to a maximum of **three** marks:

- Epidemic/pandemic outbreak (1).
- Endemic (1).
- Extreme weather (1).
- Infrastructure (1).

- Government policy (1).

James works as a public health nurse. He uses a public health approach in providing care and support for patients with obesity. James is planning on running a session for the patients to educate them on the benefits of exercise.

Explain one benefit the patients will gain from attending James' session.

Award **one** mark for each explanation point, up to a maximum of **two** marks:

- By attending James' session, the patients will meet other people with obesity (1). This will act as a support network for the patients (1).
- They will learn about different types of exercise (1) which will support them to lose weight/be healthier/increase stamina (1).
- Gives patients information as to why obesity may occur (1) and interventions that help to decrease the risk of obesity (1).
- By engaging with James' sessions, patients will be in regular contact with their healthcare provider (1). This supports continuing care for patients with obesity (1).

Accept any other suitable response.

7 You are working in a GP practice alongside the practice nurse.

At the beginning of your shift, you and the practice nurse you are working with are informed of a new safety notice. The notice states that there has been a recall on specific batch numbers of the needles the practice uses for the administration of medications. They should be returned to the manufacturer to be disposed of, in agreement with the practice's medication safety policy. This is due to safety issues with the cap on the needles. Needles from a new batch are provided. The practice's medication safety policy is followed.

You support the practice nurse by identifying the needles from the batch numbers named and immediately remove the needles from use. The practice nurse orders for the needles to be returned to the manufacturer.

Assess the importance of the practice nurse following the medication safety policy and taking appropriate action.

Your response should include reasoned judgements and conclusions.

AO3: Assessment of the importance of adhering to national policies may include:

- By removing the faulty needles and following policy, it will ensure the safety of all the patients and staff in the practice as it reduces risk of a needle-stick injury for them.
- By abiding by the safety notice and immediately removing the needles, it will provide standardised and quality care for all patients and service users who come to the practice as potential harms will be reduced.
- By removing the faulty caps from practice, it will prevent administration errors as the faulty caps may result in leakage of the medication from the needle prior to administration.
- By abiding by the medication safety policy, it will provide consistency in medication administration as it will remove the risk of errors being made.
- By abiding by the medication safety policy, this will reduce the likelihood of litigation because of patient or staff harm because of using faulty equipment.
- By abiding by the safety notice, it will ensure the safety and wellbeing of practitioners and prevent staff needing to be absent because of harm that may occur by using faulty equipment.
- By abiding by the safety notice, it will promote health and wellbeing of the staff and patients.
- By abiding by the safety notice, it will ensure that legislative expectations are adhered to and ensure that the practice does not receive any fines or investigations because of using the faulty equipment despite been advised of the fault.
- It will prevent complaints or impacts on inspection and grading.

- risks to health and safety
- spread of infection
- invalid results
- production of toxic/dangerous by products
- cross-contamination
- inefficient working practices
- · increased costs and timescales
- damage to equipment.

AO2: Application of knowledge and understanding of the impacts of not regularly cleaning and maintaining work areas related to the scenario may include:

- The risks to health and safety could lead to patient or staff harm.
- Spread of infection could result in outbreak of disease and/or illness for patients and/or staff.
- Unclean surfaces may invalidate results taken.
- Surfaces that are not cleaned could generate a build-up of toxic/dangerous products.
- Unclean surfaces have the potential for cross-contamination which may cause invalidation of patient results.
- Unclean surfaces may invalidate equipment or cause damage to equipment.

AO3: Discussion of the impacts of not regularly cleaning and maintaining work areas may include:

- If cross-contamination resulted in invalid and inaccurate patient results, it may cause inappropriate or ineffective treatments to be initiated for patients.
- This affects staff as it will lead to inaccurate diagnoses of conditions.
- In turn, if inappropriate or ineffective treatments are initiated for patients, this may result in patient harm.
- By not keeping the room clean, there is a risk of patient illness which could impact on the health and wellbeing of the patient and their ability to recover.
- By not keeping the room clean, there is a risk of staff illness which could impact on the ability of the service to provide appropriate care (for example, not cancelling patient appointments because of under-staffing).
- Cost implications for any ineffective or inappropriate treatments given.
- This could be picked up in inspections by the CQC who will impose sanctions on the service. This could affect staff morale as well as patient confidence in their care.

A hospital investigated the effectiveness of a new medication to reduce bleeding in patients who have had stomach surgery.

Investigation results are a source of data in the health and science sector.

Identify one strength and one limitation of investigation result sources.

Award **one** mark for a strength and **one** mark for a limitation of investigation results, up to a maximum of **two** marks:

Strengths:

- The method used will give consistent results (1).
- Tests are conducted under controlled conditions within the hospital (1).
- Helps to remove bias from the results (1).

Limitations:

- Possibility of over-extrapolation (for example other surgery types) (1).
- Small sample size only being in one hospital (1).

NB: Accept variables are controlled. Do not award two marks for two strengths or two limitations.

Within the health and science sector, there are restrictions on the use of social media.

Daisy is a community nurse and has taken a photograph of their desk and posted it on social media. In the back of the picture, Daisy has patient records open on their desk.

Explain how Daisy has breached the restrictions on the use of social media.

Award **one** mark for each explanation point, up to a maximum of **two** marks:

- Daisy has posted sensitive/personal information about a patient (1). This breaches the organisational policy (1).
- Daisy has posted information about a patient without their consent (1). This is a breach of patient confidentiality (1).
- Daisy has released sensitive information about a patient (1). This places the patient at risk (of harm) (1).
- Daisy has broken the Code of Conduct for Nurses (1) as they have not gained consent from the patient and/or have breached confidentiality (1).

Accept any other suitable response.

- Jeff attends hospital for his annual asthma check. He sees an information poster in the waiting room stating that the department will store data about the consultations that take place between patients and staff.
 - (i) Identify the legal requirement that governs the storage of personal data.
 - (ii) Explain why the data about Jeff's consultation should be stored.

Award **one** mark for the correct identification, up to a maximum of **one** mark:

- General Data Protection Regulations 2018 (GDPR) (1).
- The Data Protection Act (1).

Award **one** mark for each explanation point, up to a maximum of **two** marks:

- It ensures that Jeff's information is stored legally (1). Which means that the organisation will not incur financial penalties which will affect their ability to operate as usual (1).
- It allows for Jeff and staff to be able to refer to and use the policy to store and access Jeff's information appropriately (1). Staff will be able to locate data relevant to the care of Jeff and use this to make timely decisions about his care which may be time-sensitive (1).
- So that his data is not shared without his consent (1). The records will include sensitive data which could be used by others to discriminate against him, for example, potential employers, potential life insurance providers (1).
- Jeff's data will be stored as it was a medical consultation (1) so that practitioners can refer to this in future consultations (1).
- So that the information can be shared with the appropriate healthcare professionals involved in Jeff's asthma care (1) to make healthcare staff aware of Jeffs asthma care plan so they are in a position to feedback of its efficacy (1).

 So practitioners can refer back to this when updating medical records/taking a medical history in the future (1). This could support with any future consultations and provisional diagnoses (1).

Accept any other suitable response.

Alex is working as a district nurse. Alex is responsible for completing the documentation of a patient's care plan for the care agency who support the patient's activities of daily living. The care plan documents all actions that need to be taken to successfully meet the patient's needs and wishes.

Assess the importance of the accuracy, attention to detail and legibility of the patient's care plan.

Your response should include reasoned judgements and conclusions.

AO2: Application of understanding of the importance of accuracy, attention to detail and legibility of written communication:

- Alex needs to check the patient's care plan is clear to read and understand for staff, to ensure that all considerations have been made regarding the patient's needs.
- Alex should consider all activities of daily living when completing the care plan, to ensure that all the patient's needs are met by the care agency.
- Alex should gain consent from the patient and discuss with them what is included in the care plan, to ensure that they are satisfied with the plan in place to meet their needs/wishes.
- Alex will need to ensure that the care plan reflects the wishes of the patient and should consult the patient regarding what needs to be included.
- Alex will need to write legibly, avoiding abbreviations and signing the care plan entry to ensure the agency staff know who to consult if they need clarity.
- Alex should date and time the care plan, to reflect the patient's care needs at the time the care plan entry was written.
- Alex will need to effectively document the current health status of the patient, to allow staff to evaluate if the patient's health is improving or declining.

AO3: Assessment of the importance of accuracy, attention to detail and legibility of written communication:

- The patient will be content with the care received if the care plan successfully reflects their needs and wishes, as staff will be aware of how to meet their needs.
- If the care plan did not effectively reflect the patient's needs, the patient's health may be put at risk as their needs may not be met.
- The care plan should reflect the patient's current health status and clearly document any changes in care that are required to further support improvement in the patient's health.
- The care plan will need to reflect not only the wishes of the patient regarding what they do want as part of their care, but also any elements of care that they have declined.
- The importance of the documentation relates to abiding by Alex's Nursing and Midwifery Council (NMC) Code of Conduct, ensuring that communication is clear and legible.
- If the care plan does not effectively reflect the needs/wishes of the patient, it may result in liability for the organisation and/or Alex if the patient's needs are not met.
- By writing legibly and accurately, it ensures that the care plan reflects an accurate account of events regarding the interventions put in place to support the patient.
- The care plan being clearly written allows other health professionals to understand the care for the patient and to share data for integrated care.

- By writing clearly, legibly and accurately, it will help to support audit trails when looking at the patient's records for their health needs.
- By writing clearly, legibly and accurately, it will help to support future assessment of the
 patient when evaluating if their health has improved/declined and if further

Examples can be given for how independence can be promoted. These can include:

 For care staff who complete the residents' care plans, they can ensure the residents have choice, involvement and control over their methods of mobility and that this is documented.

- For staff who are involved with mobilising patients or encouraging mobility, supporting
 positive risk taking for the resident where appropriate can encourage the resident to walk
 with their frame or appropriate aid.
- Staff can help the resident to identify their strengths and assess their needs to gain confidence in mobility. Reiterate to the resident they can walk with a frame to support them.
- Staff can support the resident to do a task as they are capable, or to do it collaboratively if they ask for help.
- Staff can ensure that floors are clean, and no obstacles are in the resident's way when mobilising.
- Staff can provide nutritious meals to support muscle growth and the nutritional health of residents.
- Staff can ensure that the home has appropriate accessibility for residents to be able to mobilise around the home (for example lifts and ramps).

AO2: Application of knowledge and understanding of the importance of promoting independence by staff may include:

- Staff within the care home can support patients to build self-esteem of patients by setting achievable goals in relation to their mobility.
- By the staff providing nutritious meals, this can help to prevent muscle wastage or reduction in energy from the patients which would negatively impact the resident's mobility.
- Care staff promoting independence and help the resident to understand their capabilities for mobilising independently.
- By staff removing obstacles, this helps to prevent falls which could potentially harm patients and reduce their self-confidence and mobility.
- Staff promoting independence can help to reduce deterioration in patients' mobility and staff can recognise changes in a patient's mobility and/or patients will notice changes in their mobility more quickly.
- Staff will need to respond to any reports of deterioration in mobility and refer residents to the appropriate health professional if required (for example physiotherapy or doctor).

AO3: Discussion of the key points of the importance of promoting independence that may include:

- Students recognise how improvement in self-esteem has a positive impact on the
 willingness to mobilise independently. Students recognise improving independence could
 also reduce the need for staff to support so staff can support elsewhere.
- Students recognise how promoting independence can help staff members responsible for patients' health can help them to recognise a decline of health or mobility and can act swiftly to prevent this from worsening.
- Students recognise how promoting the independence of residents allows for staff to gain
 an understanding of their capabilities. This recognition of abilities supports staff to tailor
 their patients' care to their abilities. This help to promote person-centred care.
- Students recognise how the reduction of risks by the staff (examples including care and cleaning staff reducing falls and kitchen staff reducing nutritional decline) can support mobility to be sustained and can promote independence by supporting general wellbeing and confidence.

- Students recognise that all staff promoting independence has physical impacts for patients, improving their overall health and wellbeing (for example, cardiovascular health and mental health). (Specific examples may be used such as increasing exercise by walking and/or nutritious meals reduce cardiovascular risk.)
