What's more, all our technical and vocational qualifications come with wraparound support and resources to support learners to success every step of the way.



T Levels

T Levels are an important and transformative part of our technical portfolio, offering a high quality, workfocused alternative to A Levels for young people. They're developed in collaboration with employers, industry experts and practitioners to ensure that they will play a fundamental role in equipping the relevant sectors with the skilled workforce it needs, through developing and nurturing future talent.

The facts about T Levels:

- T Levels are two-year courses for 16-19 year olds
- They're level 3 qualifications (Post level 2, e.g. GCSE)
- They're equivalent to 3 A Levels and carry UCAS points

- Each student must complete an industry placement as part of their course, lasting 315 hours (45 days)
- T Levels are created in collaboration with employers and industry experts.

What is a TEAB?

A consultative forum of employers, professional bodies, education providers and industry experts

Made up of organisations with a significant stake in the outcomes of our qualifications A voice for the sector, representing the requirements of the relevant industries A voluntary group, committed to supporting the development of education An excellent opportunity for organisations to understand and help to shape the learning and future workforce

Our Technical Education Advisory Board (TEAB) is a voluntary consultative forum for sector professionals, employers and organisations who have a significant stake in the outcome of the qualifications that NCFE develops.

TEAB members represent their organisation and offer support in the following ways:

- Sharing industry insight and knowledge
- Validating and providing feedback on draft materials as they're developed
- Participating in the annual review process for the qualification content
- Feeding into development work to support with writing and reviewing learning resources and assessment materials
- Helping us to engage with other subject matter experts in your sector.

There are two types of stakeholders we engage with when developing qualifications and materials: Education Providers and Employers.

We consult with Education Providers who are, or could, deliver the technical qualifications from T Levels and similar complementary qualifications who are able to speak to the structure of the qualifications and suitability for teaching in the further education environment.

Additionally, we work with employers who represent the sector and are able to confirm the appropriateness of the level of the materials and their applicability for 16-19 year olds. We use the term "employer" to refer to someone who's from the sector and could therefore, theoretically, employ a T Level student in the future; there is no expectation for them to offer any employment or industry work placement.

Due to the nature of this work, TEAB members support on a voluntary basis.

Validation

What is validation?


TEAB members, alongside their colleagues, provide scrutiny of the qualifications at key milestones, reviewing and validating materials in a draft format and giving constructive feedback.

Validation occurs at stages throughout a qualification's lifecycle, so it is not possible to give an exact timeline, as this will differ dependent on the sector and qualifications most relevant to you.

We will always endeavour to give as much notice as possible to allow you to plan validation tasks into your workload, and we aim to be as flexible as possible with what we're asking you to do, but we understand that there will be times when you can't commit to completing specific validation activities. We ask that you just let us know if this is the case.

How does it work?



The materials sent to you for validation could be qualification specifications, live assessments, example answers or other teaching and learning resources. When joining the TEAB, we ask members to complete a Non-Disclosure Agreement (NDA), which protects the confidentiality of these materials. If you have filled in an NDA on behalf of your organisation, you're welcome and encouraged to involve colleagues in this validation activity to gain their insight too.

What is the impact?

Validation has a tangible impact on the materials we develop over time, incorporating industry insight into qualification materials to ensure that they are reflective of real-world practices and fit for purpose.

Some examples of feedback received on materials shared and the impact this has had across materials for our T Level qualifications can be seen below:

They said	So we
"40 minutes isn't long enough for this task. Promoting rushing work over good quality could be problematic"	Reviewed the wording around the task where it had not been made clear enough how much time students should spend
"A lot of selling is online, so why not focus on accessibility of online sales"	Amended the assessment questions to better reflect online buying
"Is there enough consideration for practical elements of the course?"	Undertook an exercise to include more practical elements into the qualification, increasing the emphasis on students exploring with different materials, techniques and processes
"Setting exams with timed tasks will not suit everyone."	While we were not able to remove timings all together because it prevents assessments being controlled, we did allocate the minimum weightings to the exam elements that we could.
