- written responses, either on a separate word processed document or in the answer space provided after each task
- screenshots. If required, you may ask the Invigilator to show you how to take and save screenshots
- audio files.

#### **Electronic Evidence**

All screenshots (and written responses, where provided electronically) should be provided in a single electronic document. Each piece of evidence should be clearly labelled as instructed in each task. The document should be saved with the following file name:

### **Scenario**

You work as a producer in a studio.

In your role you have been given the recording session files from an up-and-coming artist.

The artist has asked you to edit and mix their new song.

# Task 1 – Configuration (9 marks)

**1a.** Describe the DAW software and any other equipment you are using.

**1b.** Complete the following steps:

- create a new project in your DAW software
- set the tempo to 128 bpm
- create 3 stereo audio tracks
- create 2 software instrument tracks
- set the audio output for your monitoring equipment.

Explain how you completed these tasks.

**1c.** Complete the following steps:

- import the 3 audio files (Drums.wav, Synth.wav and Vocals.wav) onto the audio tracks so that all files start at bar 1
- import the MIDI file (Bass.mid) onto 1 of the software instrument tracks so that it starts at bar 1
- select a pre-set software instrument bass sound of your choice for the **Bass** track.



# Task 2 – Editing (9 marks)

**2a.** Use audio editing to silence the **Drum** audio track between bar 2 and bar 10.

Explain how you completed this task.

**2b.** The **Bass** MIDI part has some timing errors. Correct the timing of the **Bass** MIDI part using quantization.

Explain how you completed this task.

**2c.** Use audio editing to remove the unwanted noises on the **Vocal** track between bars 42 and 47.

Explain how you completed this task.

**2d.** Complete the following steps:

- export the song at this point to a suitable stereo format
- ensure that start and finish markers leave no more than 1 second of silence at the beginning and end of the track



**3b.** Create a new sound for your **Bass** MIDI part by editing a software instrument.

# Explain the following:

- your choice of software instrument type
- your use of timbre editing in the software instrument
- your use of envelope editing in the software instrument.

# **3c.** Complete the following steps:

- select a percussion sound for your empty software instrument track
- create an original MIDI percussion part. The part should start at bar 32 and continue until bar 66.

# Explain the following:

- how you selected the sound for the percussion part
- your musical ideas for the MIDI percussion part.

### **3d.** Complete the following steps:


- export the song at this point to a suitable stereo format
- ensure that start and finish markers leave no more than 1 second of silence at the beginning and end of the track
- save the stereo audio file as 'Surname\_Initial\_learner number\_Mix 2'.

- create a fade out for the song from bar 62 to the end of the song.

**4b.** Apply a suitable reverb to the **Vocals** track.

**4c.** Create a final mix using volume balance, panning, dynamics processing, automation and any additional effects processing that you wish to apply creatively.

Explain how you completed this task.

**4d.** Complete the following steps:

- export the song at this point to a suitable stereo format
- ensure that start and finish markers leave no more than 1 second of silence at the beginning and end of the track
- save the stereo audio file as 'Surname\_Initial\_learner number\_Mix 3'.



## **AO1 Configuration**

Learner should be able to configure the DAW correctly for a given project including creation of a new project, setting tempo, setting audio outputs and creating suitable track types. Learners should be able to save mixdowns to a suitable stereo format, label and organise work into a folder.

# **AO2 Editing**

Learner should be able to use DAW tools to effectively edit and manipulate given audio and MIDI material.

### **AO3 Musical development**

Learner should be able to add parts, edit software instruments and develop a musical arrangement based on given material.

# **AO4 Mixing**

Learner should be able to apply mixing skills including the use of balance, panning, application of effects and dynamics processing to create a stereo mixdown.
