Booking your learners for an external assessment

Some qualifications will require you to make the booking upon registration, for all others this is managed as a separate process, and it's the centre's responsibility to ensure learners are booked onto the appropriate assessment window/date.

Bookings, including re-sits, must be made via the 'Manage Bookings' screen in the <u>NCFE</u> <u>Portal</u>. Please refer to the <u>Portal User Guide</u> for further guidance.

Booking cut-off

All learners must be booked via the <u>NCFE Portal</u> by the advertised booking cut-off date in this document. Any late bookings will be subject to an additional late booking fee as detailed in our fees and pricing document for NCFE or CACHE.


If learners require reasonable adjustments these must be submitted in line with the published timescales in our <u>guidance and policy document</u>. Failure to do so may mean your learners will not have approval in place for the assessment.

Assessment date

Set date/time: The learners must sit the external assessment at these dates/times in line with our Regulations for the Conduct of External assessment. You'll need to complete the assessment variation form if the assessment date/time clashes with another external assessment/examination.

For assessments with published starting times, centres are enabled to start assessments by up to 30 minutes earlier than, or later than, the published starting time without the requirement to submit an assessment variation request for approval. If the amendment to time is greater than 30 minutes, prior approval must be agreed. For V Cert NEAs for 2024/25, the live brief will be published on 2 September 2025. Centres will be able to start the assessment only when all teaching and learning of the full qualification



Assessment window

At the beginning of delivering the qualification, you must plan all supervised and/or invigilated sessions within the published assessment window. Assessment timetables may be checked by External Quality Assurers or Assessment Audit Advisors during any centre quality assurance visit.

For the V Cert NEAs for 2024/25, centres must plan sufficient time with contingency to ensure all assessments are complete and learner marks can be entered into the Portal no later than 30 April 2025.

Pre-release/stimulus materials

For any external assessments where prerelease/stimulus assessment materials are required, these will be provided a minimum of 5 working days (unless otherwise stated) prior to the date of the external assessment/start of the assessment window. Please refer to the QSID for further information.

Return of external assessments

Partially or fully completed learner work, and the External assessment Register(s)/Submission List, must be returned to NCFE by special delivery/secure courier within 2 working days (3 working days for digitally uploaded work) of the external assessment taking place or the final timetabled supervised/invigilated session. Should the published date or end date of an assessment fall on the final day of a term or half-term, centres must make arrangements to have papers sent or uploaded (if appropriate) on this final day, should relevant staff (e.g., IT support, Examinations Officers) be unavailable on the following working day.

Late return fees will apply to any completed external assessment material that is not received 72 hours after the external assessment.

For the <u>Level 3 Applied General in Art and Design</u>, learner work must be retained securely at the centre in preparation for the Examiner Visit.

Submission of V Cert non-exam assessment (NEA)

The deadline for submitting assessment marks for the NEA is 30 April each year. On 1 May a sample plan list will be generated on the system, and you'll have 3 working days in which to upload all of the learner evidence, feedback sheets and checklists. Please refer to the checklist in each assessment pack for specifics of what documents are required to be uploaded.

Learner marks and evidence must be submitted by the specified dates to guarantee results are issued in line with published result release dates.

Results release

The external assessment results will be released on the date highlighted for each assessment opportunity, specific to the qualification. You will be notified if any results are placed on hold and the reason why. Results can be viewed in the NCFE Portal.



V Certs - New model with delivery from September 2022

From September 2022 we launched 11 new V Cert qualifications. Some are updated versions of existing V Certs, and others cover brand new subject areas.

These new style V Certs have a single external assessment each year and a single non-examination assessment (NEA), timetabled in the summer. These assessment dates will be released 1 year in advance, and the first assessments took place in Summer 2024. This means that this version of our timetable, covering 2024-26, contains a confirmed date of Summer 2025 and a provisional date for summer 2026.
